Title of Information Collection: Development of an Evaluation Protocol for Assessing Impacts of OMH State Initiatives.

Use: This request for clearance involves modification of the OMB approved Office of Minority Health (OMH) Uniform Data Set (UDS) (OMB No. 0990-275). The UDS is the regular system for reporting program management and performance data for all OMH-funded activities. The modifications to the UDS requested in this application are intended to: (1) Accommodate grant program that were not required to use the UDS at the time the system was developed; and (2) continue the development of the UDS as a reporting system that will capture the types of data needed to identify best practices and assess the progress of OMH-funded activities. The UDS has been implemented with 8 sets of grantees and cooperative agreement

partners from 5 OMH funding programs. The recommended modifications will allow reporting by OMH partners receiving funding through the State Initiatives and Umbrella Cooperative Agreement programs. These changes will improve OMH evaluation and planning capacities and support program accountability.

Frequency: Reporting Semi-annually.
