### iShares Trust, et al.; Notice of Application

February 16, 2010.

**AGENCY:** Securities and Exchange Commission ("Commission").

**ACTION:** Notice of application to amend a prior order under section 12(d)(1)(J) of the Investment Company Act of 1940 ("Act") for an exemption from sections 12(d)(1)(A) and (B) of the Act.

**SUMMARY OF APPLICATION:** Applicants request an order ("Order") to amend an existing order that permits certain registered open-end management investment companies ("Investing Management Companies") and unit investment trusts ("UITs," collectively with Investing Management Companies, "Investing Funds") to acquire shares of other registered open-end management investment companies and unit investment trusts ("UITs") that operate as exchange-traded funds ("ETFs") and are outside the same group of investment companies as the Investing Funds ("Original Order").<sup>1</sup> The Order would modify certain conditions of the Original Order to permit: (a) Investing Management Companies that are subadvised by an investment adviser to such ETFs (or an affiliated person of the investment adviser) to acquire shares of the ETFs, and (b) Investing Funds to acquire shares of a series of iShares Trust that carries out its investment strategies by investing in a wholly owned subsidiary.

("Corporation"), BlackRock Fund Advisors ("BFA"), BlackRock Advisors, LLC, BlackRock Capital Management, Inc., BlackRock Institutional Management Corporation, BlackRock Financial Management, Inc., BlackRock International Limited, and BlackRock Investment Management, LLC (collectively with BFA, "BlackRock Advisers").
