SUPPLEMENTARY INFORMATION: The National Agricultural Research, Extension, Education, and Economics Advisory Board was established in 1996 via Section 1408 of the National Agricultural Research, Extension, and Teaching Policy Act of 1977 (7 U.S.C. 3123) to provide advice to the Secretary of Agriculture and land-grant colleges and universities on top priorities and policies for food and agricultural research, education, extension and economics. Section 1408 of the National Agricultural Research, Extension, and Teaching Policy Act of 1977 (7 U.S.C. 3123) was amended by the Farm Security and Rural Investment Act of 2008 by deleting six membership categories in the National Agricultural Research, Extension, Education, and Economics Advisory Board, which totals 25 members. Since the Advisory

Boards inception by congressional legislation in 1996, each member has represented a specific category related to farming or ranching, food production and processing, forestry research, crop and animal science, land-grant institutions, non-land grant college or university with a historic commitment to research in the food and agricultural sciences, food retailing and marketing, rural economic development, and natural resource and consumer interest groups, among many others. The Board was first appointed by the Secretary of Agriculture in September 1996 and onethird of its members were appointed for a one, two, and three-year term, respectively. The terms for 9 members who represent specific categories will expire September 30, 2015. Nominations for a 3-year appointment for these 9 vacant categories are sought. All nominees will be carefully reviewed for their expertise, leadership, and relevance to a category.

The 9 slots to be filled are:

Category A. National Farm Organization Category C. Food Animal Commodity

- Producer Category I. National Human Health
- Association
- Category N. Non-Land Grant College or University w/historic commitment to research in food and agricultural sciences
- Category O. Hispanic-serving Institutions
- Category Q. Transportation of Food and Agricultural Products to domestic and foreign markets
- Category R. Food Retailing and Marketing Interests
- Category S. Food and Fiber Processors
- Category X. Private Sector Organization involved in International Development

Nominations are solicited from organizations, associations, societies, councils, federations, groups, and companies that represent a wide variety of food and agricultural interests throughout the country. Nominations for one individual who fits several of the categories listed above, *or* for more than one person who fits one category, will be accepted. In your nomination letter, please indicate the specific membership category for each nominee. Each nominee must submit form AD-755, "Advisory Committee Membership Background Information" (which can be obtained from the contact person below or from: http://www.ocio.usda.gov/sites/ default/files/docs/2012/AD-755 Master 2012 508%20Ver.pdf). All nominees will be vetted before selection.

Nominations are open to all individuals without regard to race,

color, religion, sex, national origin, age, mental or physical handicap, marital status, or sexual orientation. To ensure the recommendation of the Advisory Board take into account the needs of the diverse groups served by the USDA, membership shall include, to the extent practicable, individuals with demonstrated ability to represent the needs of all racial and ethnic groups, women and men, and persons with disabilities.

Please note that registered lobbyist and individuals already serving another USDA Federal Advisory Committee, are ineligible for nomination.

Appointments to the National Agricultural Research, Extension, Education, and Economics Advisory Board will be made by the Secretary of Agriculture.

Notice of New Recreation Fee

AGENCY: Plumas National Forest, Forest Service, USDA.

ACTION: Notice of new recreation fee; Federal Lands Recreation Enhancement Act, (Title VIII, Pub. L. 108–447).

SUMMARY: The Plumas National Forest is proposing to add Crocker Guard Station to the recreation rental program. The proposal is to charge \$85.00 per night. The house has four bedrooms with a total of nine beds, a living room, a dining room and a kitchen. A vault toilet building was installed in June 2015. The rental building will have a propane operated heater, stove and lights. Visitors will have to bring water. The building will accommodate up to 16 people.

Fees are assessed based on the level of amenities and services provided, cost of operation and maintenance, market assessment and public comment. The fee listed is only proposed and final determination will be made upon further analysis and public comment. Other cabin rentals on National Forests in California have shown the public appreciates the enhanced recreational opportunity offered by these rehabilitated historic structures. Revenue from the fees would be retained locally and used for the operation and maintenance of the facility, and for future improvements.

DATES: Send any comments about this fee proposal by January 15, 2016 so comments can be compiled, analyzed and shared with the Recreation Resource Advisory Council (RRAC) prior to final decision and implementation by the Regional Forester, Region 5, USDA Forest Service. If approved, the rental would be available in April 2016.

SUPPLEMENTARY INFORMATION: The Federal Recreation Lands Enhancement Act (Title VII, Pub. L. 108–447) directed the Secretary of Agriculture to publish a six month advance notice in the Federal Register whenever new recreation fee areas are established.

This proposed new fee will be reviewed by a Recreation Resource Advisory Committee prior to a final decision and implementation.

The Plumas National Forest currently has one cabin rental, which is booked regularly throughout the season of operation. The public has expressed interest in additional cabin rental opportunities on the Forest.

People wanting to rent Crocker Guard Station will need to do so through the National Recreation Reservation Service, at *www.recreation.gov* or by calling 1-877-444-6777. The National **Recreation Reservation Service charges** a \$9 fee for online reservations and a \$10 fee for phone reservations.

Carbon and Certain Alloy Steel Wire Rod From Mexico: Amended Final Results of Antidumping Duty Administrative Review; 2012–2013

AGENCY: Enforcement and Compliance, International Trade Administration, U.S. Department of Commerce. **SUMMARY:** The Department of Commerce ("Department") is amending the Final Results¹ of the administrative review of the antidumping duty order on carbon and certain alloy steel wire rod from Mexico to correct ministerial errors. The period of review ("POR") is October 1, 2012, through September 30, 2013.

Background

On May 11, 2015, the Department disclosed to interested parties its calculations for the Final Results.² On May 18, 2015, we received ministerial error allegations from Petitioners³ and Deacero S.A.P.I de C.V. and Deacero USA ("Deacero") regarding the Department's final margin calculations.⁴ On May 26, 2015, Deacero submitted rebuttal comments to Petitioners' allegations.⁵

Period of Review

The POR covered by this review is October 1, 2012, through September 30, 2013.

Scope of the Order

The merchandise subject to this order is carbon and certain alloy steel wire rod. The product is currently classified under the Harmonized Tariff Schedule of the United States (HTSUS) item numbers 7213.91.3010, 7213.91.3090, 7213.91.4510, 7213.91.4590, 7213.91.6010, 7213.91.6090, 7213.99.0031, 7213.99.0038, 7213.99.0090, 7227.20.0010, 7227.20.0020, 7227.20.0090, 7227.20.0095, 7227.90.6051, 7227.90.6053, 7227.90.6058, and 7227.90.6059. Although the HTS numbers are provided for convenience and customs purposes, the written product description remains dispositive.6

Ministerial Errors

Section 751(h) of the Tariff Act of 1930, as amended ("the Act"), and 19 CFR 351.224(f) define a "ministerial error" as an error "in addition, subtraction, or other arithmetic function, clerical error resulting from inaccurate copying, duplication, or the like, and any similar type of unintentional error which the Secretary considers ministerial." We analyzed Petitioners' and Deacero's ministerial error comments and determined, in accordance with section 751(h) of the Act and 19 CFR 351.224(e), that there were three ministerial errors in our calculation of Deacero's margin for the Final Results. For a complete discussion of these allegations, see the Department's Ministerial Errors Memorandum.7

In accordance with section 751(h) of the Act and 19 CFR 351.224(e), we are amending the Final Results.⁸ The revised weighted-average dumping margin is detailed below.

Amended Final Results

As a result of correcting for these ministerial errors, we determine the following margin exists for the period October 1, 2012, through September 30, 2013.
