The Committee for Purchase From People Who Are Blind or Severely Disabled (Committee) received comments from one firm objecting to the addition. The firm stated it is the incumbent contractor for the General Services Administration, and loss of the ability to compete for the future contract will negatively impact the firm's business. In the normal competitive procurement process, there are no guarantees of continuous contracts. Further, the Committee reviewed and applied its standard impact analysis methodology to the information submitted by the firm. The Committee determined, in accordance with its longstanding business practices, that addition of Gloves, Blue Nitrile (Industrial) to the Procurement List would not result in a severe adverse impact.

The Committee operates pursuant to statutory and regulatory requirements. The Committee's mission is to create

employment opportunities for people who are blind or severely disabled. Committee regulation 41 CFR 51-2.4 states that for a commodity or service to be suitable for addition to the Procurement List, each of the following criteria must be satisfied: (1) the addition to the Procurement List must demonstrate a potential to generate employment of people who are blind or have other severe disabilities; (2) the nonprofit agency proposing to provide the product or service to the Federal Government must be qualified to participate in the AbilityOne program as defined in separate Committee regulations; (3) the nonprofit agency must prove itself capable to deliver the product or service at the quality standard and delivery schedule required by the Government; and (4) the Committee reviews the level of impact on the current contractor for the commodity or service.

SUMMARY: The Department of Defense (DoD) is publishing this notice to announce that it is renewing the charter for the National Intelligence University Board of Visitors ("the Board").

accordance with the Federal Advisory Committee Act (FACA) of 1972 (5 U.S.C., Appendix, as amended) and 41 CFR 102–3.50(d). The Board's charter and contact information for the Board's Designated Federal Officer (DFO) can be found at *http://www.facadatabase.gov/*.

The Board provides the Secretary of Defense and the Deputy Secretary of Defense, through the Under Secretary of Defense for Intelligence (USD(I)), the Director, Defense Intelligence Agency, and the President of the National Intelligence University, independent advice and recommendations on matters related to mission, policy, accreditation, faculty, students, facilities, curricula, educational methods, research, and administration of the National Intelligence University.

The Board shall be composed of no more than 12 individuals, who have extensive professional experience in the fields of national intelligence, national defense, and academia. All members of the Board are appointed to provide advice on behalf of the Government on the basis of their best judgment without representing any particular point of view and in a manner that is free from conflict of interest. Except for reimbursement of official Board-related travel and per diem, Board members serve without compensation.

The DoD, as necessary and consistent with the Board's mission and DoD policies and procedures, may establish subcommittees, task forces, or working groups to support the Board, and all subcommittees must operate under the provisions of FACA and the Government in the Sunshine Act. Subcommittees will not work independently of the Board and must report all recommendations and advice solely to the Board for full deliberation and discussion.

Subcommittees, task forces, or working groups have no authority to make decisions and recommendations, verbally or in writing, on behalf of the Board. No subcommittee or any of its members can update or report, verbally or in writing, directly to the DoD or any Federal officers or employees. The Board's DFO, pursuant to DoD policy, must be a full-time or permanent parttime DoD employee, and must be in attendance for the duration of each and every Board/subcommittee meeting. The public or interested organizations may submit written statements to the Board membership about the Board's mission and functions. Such statements may be submitted at any time or in response to the stated agenda of planned Board. All written statements must be submitted to the Board's DFO who will ensure the
