##### Large Diameter Welded Pipe From the People's Republic of China: Countervailing Duty Order

**AGENCY:** Enforcement and Compliance, International Trade Administration, Department of Commerce.

**SUMMARY:** Based on affirmative final determinations by the Department of Commerce (Commerce) and the International Trade Commission (ITC), Commerce is issuing a countervailing duty order on large diameter welded carbon and alloy steel structural pipe from the People's Republic of China (China).

#### SUPPLEMENTARY INFORMATION:

##### Background

On November 14, 2018, Commerce published its affirmative final determination in the countervailing duty investigation of large diameter welded pipe from China.<sup>1</sup> The scope of the investigation in Commerce's final determination covered large diameter welded carbon and alloy steel line pipe (welded line pipe), large diameter welded carbon and alloy steel structural pipe (welded structural pipe), and stainless steel large diameter welded pipe (stainless steel pipe) from China.<sup>2</sup> As discussed below, the ITC

subsequently found three domestic like products covered by the scope of the investigation (welded line pipe, welded structural pipe, and stainless steel pipe) and accordingly made a separate injury determination with respect to each domestic like product. On January 30, 2019, the ITC notified Commerce of its final determination, pursuant to section 705(d) of the Tariff Act of 1930, as amended (the Act), that an industry in the United States is materially injured within the meaning of section 705(b)(1)(A)(i) of the Act by reason of subsidized imports of welded structural pipe from China.<sup>3</sup> Additionally, the ITC made a negligibility determination with respect to welded line pipe and a negative determination of material injury or threat of material injury with respect to stainless steel pipe.<sup>4</sup> On February 13, 2019, Commerce released draft revised scope language for comment by parties. American Cast Iron Pipe Company, Berg Steel Pipe Corp., Berg Spiral Pipe Corp., Dura-Bond Industries, Stupp Corporation, Greens Bayou Pipe Mill, LP, JSW Steel (USA) Inc., Skyline Steel, Trinity Products LLC, and Welspun Corp., Ltd. (collectively, the petitioners) provided comments, which we have incorporated into the final scope of the order.<sup>5</sup>

##### Scope of the Order

The product covered by this order is welded structural pipe from China. For a complete description of the scope of this order, see the Appendix to this notice.

##### Countervailing Duty Order

On January 30, 2019, in accordance with section 705(b)(1)(A)(i) and 705(d) of the Act, the ITC notified Commerce of its final determination in this investigation, in which it found that imports of welded structural pipe are materially injuring a U.S. industry.<sup>6</sup> As a result, and in accordance with section 705(c)(2) and 706 of the Act, we are publishing this countervailing duty
